### **A Word from the Secretary**

Since our last newsletter in October, I have been able to gather additional or corrected information on our cemetery records. Each bit of information I receive is documented and a paper trail is kept on each lot. Some information that I do not have, but would like to have, is a copy of deeds or certificates of title on all lots to add to the files. If you have this documentation and would like to share it with the association "just for the record," it would be most appreciated. You may send it to me at the address on the front of this newsletter.

Several people have expressed an interest in purchasing burial spaces in Frankford Cemetery. Initially, I created a listing of vacant burial spaces according to information in the records. Then I sent a letter to each of those lot owners asking if they were interested in selling spaces on their lots. Many lot owners contacted me to let me know they were not interested in selling, so they were taken off the list. I have since learned there are others who do not wish to sell, so their names have been removed, as well. The association does not sell burial spaces, but we can help put buyer and seller together.

Thanks to all of you who have shared information with me regarding the burial records. All information is appreciated and is now included in the records. I will have a copy of your lot records available on Decoration Day if you do not already have a copy. I will need your lot number in order to locate the record quickly. Looking forward to seeing you there.

## **November Dinner on the Grounds**

The first annual fall Dinner on the Grounds was held November 2, 2008. Over a hundred attended and enjoyed a delicious chicken dinner near the beautiful old tree behind the church. Everyone seemed to enjoy this occasion so much that the board decided to make it an annual event. We hope that our two annual events, Decoration Day in May, and Dinner on the Grounds in November will help us continue to rebuild a sense of community at Frankford.

## **Cemetery Courtesy and Protocol**

On Decoration Day weekend many Frankford families will visit the cemetery to place flowers on graves of loved ones. Some folks like to do a little gardening on their plots as well. With just one main access into the cemetery (the concrete drive in the middle) it is easy for vehicles to get wedged in between other vehicles and unable to exit the cemetery. To avoid this frustrating situation the board asks everyone decorating graves or visiting the cemetery during Decoration Day weekend to follow this protocol:

Park outside the cemetery if at all possible. If you must park on the drive in the middle of the cemetery—please, no more than two vehicles on the drive at a time. Be alert to the need to back out your vehicle if the person in front of you needs to leave.

\*\*\* Please, no vehicles on cemetery grounds (other than the concrete drive). Funeral home vehicles are the only vehicles allowed on the cemetery grounds.

## **Frankford Church Restoration Fund**

## **FCA Projects**

Plans to restore the church are underway. The board has hired a construction manager to make necessary repairs, being sensitive to the historical integrity of the church. Plans will be approved by the Texas Historical Commission to ensure that the church maintains its designation as a Recorded Texas Historic Landmark (RTHL). The actual work should start by this summer and end in December 2009. We know that many join in the excitement about breathing new life into our little prairie church, which we believe is a jewel.

Plans are underway for a Frankford Cemetery Association website that will contain general information about the association, its history and upcoming plans.
